PCN10-2018 (Dragster-PCR-03) Glass cover tape

Dear Customer,

In order to improve the current glass protective cover tape applied to all CMOS Line scanner products, a new tape material will now be introduced. The tape for protection PID8000 features a Polyimide carried single coated adhesive tape suitable for image sensor Protection (CCD, CMOS etc.).

Impact on packing & shipment

There will be a change in the material used for the glass protective tape. Current design, size and packaging specifications of the cover tape and the end sensor packaging spec. will not be updated.

Traceability

The application of the new tape will be tracked by the starting batch number for all sensor variations at the Subcon.
